The Kenan Center's 100 American Craftsmen is one of Western New York's premiere craft shows, a three-day extravaganza featuring the works of more than 100 artisans, specialty food vendors, musicians, wineries, and demonstrators. The Annex Marketplace at 100 American Craftsmen is an innovative space that offers first time and emerging artisans the opportunity to exhibit and sell their work alongside that of some of the most respected artisans in our region.

The show welcomes more than 3,000 guests each year over the three days and gives our Annex artisans the exposure they need to establish themselves in the craft art community.

APPLICATION INFORMATION, DEADLINES, AND FEES

To apply to the Annex Marketplace at 100 American Craftsmen, each artisan entrant must fill out the attached application and submit two (2) photographs of their work and one (1) photograph of the booth setup (if available). Images must be of current work and representative of work artisan plans to exhibit at the show for consideration by the jury. Applications and images should be submitted by email to alysamays@kenancenter.org. Application form may be mailed separately to Kenan Center, 433 Locust Street, Lockport, NY 14094, Attn: Annex Marketplace. **The deadline for all applications is April 23, 2018.**

Accepted artisans will be notified no later than April 30, 2018. After receiving notification of acceptance into the Annex Marketplace, an exhibit fee of \$100.00 is due no later than May 7, 2018. Checks can be made payable to: Kenan Center, and mailed to 433 Locust Street, Lockport, NY 14094.

ELIGIBILITY

The Annex Marketplace is open to artisans who are Emerging--those who have been working at their craft for six (6) years or less; who have not previously exhibited in 100 American Craftsmen, and/or who are a student. Minimum age for applying is 15 years old. All exhibitors are expected to collect sales tax and remit to New York State as required by law.
